# Rising Stars definition:

 Any reinstated / reappointed agent (with new agent's code or old agent's code with less than 12 months from the date of last termination) or direct appointment (DAAD) will not be counted as Rising Star.



# Rising Star is applicable to new agents' category only

 a. Rewards are non- exchangeable and non- redeemable for cash except for medical reason/immigration cases

# Special Leader Category is applicable to Agency Leaders Direct Unit category only

- a. The count of min 3 qualified and participating Rising Star is excluding him/herself within the campaign year period.
- b. Rewards are non- exchangeable and non- redeemable for cash.
- c. Entitlement is for 1 trip package only throughout the campaign period of 2023

## <u>Terms & Conditions for AIT Rising Star Incentive Trip:</u>

- This incentive trip is solely for qualified Rising Star and Leaders (Direct Unit who have at least minimum of 3 qualified Rising Stars in 2023) qualifying for Special Leaders Category.
- Rising Star is defined as those agents who are registered from January 2023
   December 2023.
- 3. All qualifiers compulsory to attend the "eStar Program' training within 90 days or 180 days from contracted date to participate in the trip.
- 4. Note for Rising Star Trip;
  - i. Must achieve minimum number of 30 participants for every trip otherwise company has the right to cancel the trip and all qualifiers will be compensating with the max of 75% from the total package trip (for whatever reason/ground).
  - ii. All qualifiers are not allowed to opt for the next trip (must stick with grouping decide by the company) and if you fail to follow the time table given by the company, company has the right to pay the max 75% from the total package trip
- 5. Only in forced submissions within the said campaign period is counted for the reward.
- 6. Strictly no Single Top-up or Regular Top Up contribution will be included in AIT Rising Star calculation.
